EDUCATION AND EXPERIENCE:

Jean-christophe Prin earned his Master of Acupuncture and Oriental Medicine degree from the Atlantic Institute of Oriental Medicine in Fort-Lauderdale Florida, in April 2007. This four-year program consists of 2,800 hours of education including 875 hours of clinical practice. He was certified as a Diplomate in Acupuncture and Traditional Chinese Medicine by the National Certification Commission for Acupuncture and Oriental Medicine (NCCAOM) in July 2007. This includes certification in Clean Needle Technique and Chinese Herbology.

Prior to earning his Master degree in the United States, Jean-christophe Prin graduated from "Institut Chuzhen de Medecine Chinoise" in Paris, France, and received a Master of Acupuncture in August 2003. Before graduating from "Institut Chuzhen" in Paris, Jean-christophe interned in the "First Teaching Hospital" in Tianjin, China for 4 months, providing acupuncture and tuina in different departments of the hospital.

He then practiced acupuncture in his own clinic in Nantes, France until moving to Miami, FL in 2004.

Jean-christophe's training includes adjunctive therapies such as moxibustion, tui na, acupressure, cupping, auriculotherapy, dietary and lifestyle recommendations.

Jean-christophe is a member of the Acupuncture Association of Colorado. He is a registered and licensed acupuncturist in Colorado. None of these licenses, certificates, or registrations has ever been suspended or revoked.

This clinic complies with the rules and regulations promulgated by the Colorado Department of Health, including the proper cleaning and sterilization of needles and the sanitation of acupuncture offices. Only single-use, disposable, factory-sterilized needles are utilized.
